5. No early dismissal, unless prior arrangements have been made. Attendees must sign out upon departure.
6. JCS Rules of Student Discipline will be enforced for all students and guests. Cooperation with all adult supervisors is required.
7. No tobacco, drugs or alcohol is permitted. Anyone who arrives under the influence of alcohol or any other controlled substance will be denied entrance to the dance and is subject to disciplinary action and possible arrest.
8. Attendees must maintain a certain level of decorum. Dance movements and mannerisms should fall within the standards of social acceptability and good taste. 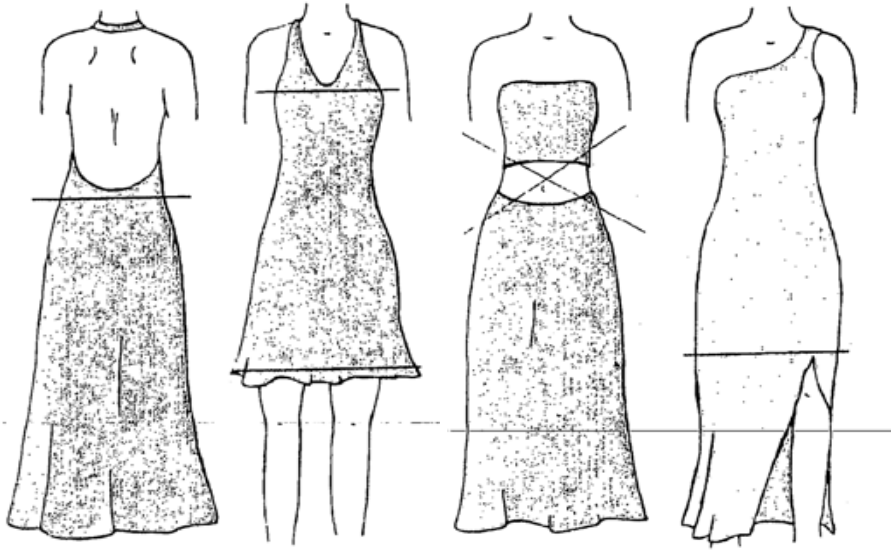
